- Increasing number of (published) papers from outside Europe (China, Iran, Brazil). B-I-F account for 22% of published research papers.
- Overall picture: rather quiet year, mostly business as usual, with improved quality and visibility.

General Assembly meeting at HEC Liège on Thursday Feb. 1st, 2018 Annual report of activities in 2017

Dear Chairman, Dear Members of the Administration Board, Dear Members of ORBEL,

As now traditional I will first be giving headlines on the ORBEL 31 conference at KU Leuven Brussel Campus, the ORBEL and Wolsey awards 2017, and news from other activities of our society in 2017.

The 31st yearly national ORBEL conference on Operations Research was organised by our administrators Jeroen Beliën (Conference chair) and Dries Goossens (Programme chair) at the KU Leuven Campus Brussels on Thursday & Friday February 2-3, 2017. Many thanks to them and their committees for the very successful conference with an important attendance: 152 participants (53 regular and retired and 99 students). Two distinguished invited plenary speakers took the floor: James J. Cochran Head of the Department of Information Systems, Statistics and Management Science at the University of Alabama with the very refreshing talk "Active learning in the modern Operations Research classroom: reengaging and reenergizing your students and their instructor!", and Marco Lübbecke, Chair of Operations Research at the RWTH Aachen University, with the talk "Branch-and-price" dealing with optimisation problems with an enormous number of variables. The conference dinner took place in Radisson Blu Royal Hotel, at a stone-throw from the Campus and Brussel's Market Square. The conference result brought an excellent net profit of 2800 Euro and in addition 2915 Euro of ORBEL membership fees.

The ORBEL and the Wolsey awards were as now traditional received during the conference.

The ORBEL 2017 award sponsored by OM Partners with 1000 EURO award is bestowed on the author(s) of a scientifically oriented Master's thesis presented in 2016. The jury, presided by Frits Spieksma, selected among four very valuable candidates Lisa D'haeseleer of Ghent with her thesis entitled 'Central allocation of pupils to schools'; her promoter was Dries Goossens. Note that this is the last time that Frits will be chairing the award jury: Jeroen Beliën has accepted to take over from 2018 on.

Thank you very much Jeroen on behalf of ORBEL!

The Wolsey award organised by N-side is rewarded each year with an iPad and a full registration to the ORBEL conference to the author(s) of the best and most significant OR implementation contributing to Open-Source. The laureate for the Wolsey award 2017 was Guillaume Derval of UCL with his work 'OscaR-Modeling, a modeling layer for OscaR including transparent parallelism'.

Congratulations to both laureates!

Regarding 4OR, the Editor-In-Chief Yves Crama will provide for the minutes the activity report on Volume 15 published in 2017.

In 2017 three activities were organised by members of the ORBEL administration board, and received a financial support from ORBEL.

- Urban Public Transport Operations Research Seminar 2017, organised by Pieter Vansteenwegen in KU Leuven on 29th September 2017.
- Computer in Scientific Discovery 8, organised by Hadrien Mélot in UMons on 23-26 August 2017 gathering researchers making connections between mathematics, computer science, chemistry, biology and physics.
- 12th International Workshop on Cutting, Packing and Related Topics, organised by Tony Wauters in KULeuven (campus Gent) on 23-26 August 2017.

EURO-News:

- In 2017 Túlio Toffolo (KUL) was selected by EURO to attend ELAVIO XXI, Latin-American Summer School in Operations Research, which took place in Buenos Aires and Miramar (Argentina) from February 24th to March 4th, 2017. - Martine Labbé (ULB) was EURO Plenary Speaker at IFORS 2017 in Quebec City.
